## April 2023 Information Sheet

Present Water Rates: First 3,000 Gallons - \$21.86 (minimum)  
3,100 Gallons – 8,000 Gallons - \$3.59 / 1,000 Gallons  
8,100 Gallons and over - \$3.73 / 1,000 Gallons

(A 4% utility tax will be added to all water sales; therefore, our minimum bill is \$22.73)

Present Connection Fee: \$600 for New Service (3/4 x 5/8 Meter)  
Present Service Charge: \$125.00 to Establish an Account

**Total for Residence: \$725.00**

**Total for Business and Rental: \$725.00**

Present Sprinkler Meter Fee: \$200.00

NOTE: Both Connection Fees and Minimum Bills are Higher for Larger Meters

### Other Charges Include:

- \$1.00 Maintenance Fee for all residents.
- \$25.00 Fee for turning water on & off for the convenience of the customer.
- \$30.00 Fee for customer checks not honored by bank (NSF). All fees must be paid by cash / money order.
- \$50.00 Fee for Fire Line.
- \$55.00 Fee for Reconnection after disconnection for non-payment.
- \$100.00 Fee for tampering with meter or cut lock / zip tie / curb stop.
- \$200.00 Fee for direct hook-ups without a meter.
- \$250.00 Fee for damage to meter / node.
- 10% of Bill or \$5.00 Late Charge for all bills not paid by the 15<sup>th</sup> of each month (whichever is greater)

**Disconnects on accounts are done after the 15<sup>th</sup> day of the month on any past due account. If account is disconnected due to non-payment, all fees must be paid before service is reconnected. This includes all reconnection fees or late charges.**

Regarding the adjustment of bills because of a customer leak, the Authority will allow the customer credit only for a bill that is \$25 over a normal average water bill. This adjustment is only allowed once in a twelve (12) month period, and a receipt for plumbing repairs must be submitted to the Authority.
