Information Sheet

Present Water Rates: First 3,000 Gallons - \$24.36 (minimum)
3,100 Gallons – 8,000 Gallons - \$4.00 / 1,000 Gallons
8,100 Gallons and over - \$4.15 / 1,000 Gallons

(A 4% utility tax will be added to all water sales; therefore, the minimum bill is \$25.33.)

Present Connection Fee: \$1,000.00 for New Service (3/4 x 5/8 Meter)

Present Service Charge: \$ 125.00 to Establish an Account

Total for Residence: \$1,375.00

Total for Business and Rental: \$1,375.00

Present Sprinkler Meter Fee: \$ 400.00

NOTE: Both Connection Fees and Minimum Bills are Higher for Larger Meters

Other Charges Include:

- \$1.00 Maintenance Fee for all residents.
- \$1.44 Water Improvement Fee for all residents.
- \$20.00 Collection Fee.
- \$25.00 Fee for turning water on & off for the convenience of the customer.
- \$30.00 Fee for customer checks not honored by bank (NSF). All fees must be paid by cash/money order.
- \$50.00 Fee for fire line.
- \$55.00 Fee for reconnection after disconnection for non-payment.
- \$100.00 Fee for tampering with meter or cut zip-tie.
- \$200.00 Fee for cut lock/curb-stop.
- \$200.00 Fee for direct hook-ups without a meter.
- \$500.00 Fee for damage to meter.
- \$140.00 Capacity Fee for Mobile Home Park/Apartment (each unit).
- \$250.00 Capacity Fee for Single Family.
- 10% of Bill or \$5.00 Late Charge for all bills not paid by the 15th of each month.
(whichever is greater)

Disconnects on accounts are done after the 15th day of the month on any past-due accounts. If the account is disconnected due to non-payment, all fees must be paid before the service is reconnected. This includes all reconnection fees or late charges.

If service has been terminated, a new connection fee will be required to restore service.

Regarding the adjustment of bills because of a customer leak, the Authority will allow the customer credit only for a bill that is \$25 over a normal average water bill. This adjustment is only allowed once in a twelve (12) month period, and a receipt for plumbing repairs must be submitted to the Authority.
